COVID-19 Update as of May 5, 2020

Case Numbers Continue Increasing, Residents Urged to Wear Face Coverings


The City of El Paso Public Health Department is reporting **51** new COVID-19 cases bringing the county's cumulative number to **1,080**, the number of deaths remains at **22**.

To-date **514** people have recovered from COVID-19; consequently, there are **544** active cases within the county. Positive cases in El Paso County include 569 females and 511 males; see accompanying graphics and map. There are 71 patients who are hospitalized, and 40 of those hospitalized are currently in ICU.

While private labs are only required to report positive numbers, the Department of Public Health has been working with the private laboratories to obtain their total numbers. Based on this reporting, it is estimated that more than 10,200 tests have been performed.

The Public Health Department will soon begin antibody testing with a subset of public safety and healthcare workers to allow staff to analyze the process in preparation to expand the special testing to the public. Antibody testing is a blood test that indicates if a person may have previously been exposed to COVID-19 and developed antibodies.

City and County officials are in the process of reviewing the current Local Emergency Directive in response to today's Governor Greg Abbott's amendments to expand business openings in an effort to re-open the Texas economy.



"We can only continue to re-open our economy if the community does their part to social distance, wear face coverings and not gather," said Mayor Dee Margo. "It is critical everyone, businesses and residents, follow these guidelines so we do not jeopardize our public health."

Dr. Hector Ocaranza, City/County Health Authority, reminds the public that El Paso County is still seeing positive cases on a daily basis and for that reason must still work to protect themselves and their loved ones.

"If you love your mom, grandmothers, aunts, sisters, any mother figure in your life show them your love them by not visiting them in person this Mother's Day.

Give them the gift of health and life, and keep them safe from COVID-19," Ocaranza said. "Stop making excuses on why it is ok to visit family members and friends who do not live in your immediate household. Social gatherings are simply not allowed. Meaning social gatherings consist of anyone who does not live in your immediate household, such as aunts, uncles, grandparents, etc. are prohibited. We need everyone to please take this serious and take care of each other and not risk losing a loved one."

The public is reminded again that face coverings are locally mandated, but they are not required on anyone who has trouble breathing, is unconscious, incapacitated, or exercising outdoors and not within 6 feet of any other individual not from the same household. Wearing a face covering is not a substitute for maintaining 6-feet social distancing and hand washing, as these remain important steps to slowing the spread of the virus.

It is recommended that face coverings be cleaned daily. Individuals should be careful not to touch their eyes, nose and mouth when removing their face covering and wash their hands before and after removing the covering.

Residents are encouraged to report non-compliance by calling the police department non-emergency at (915) 832-4400. Anyone with questions about the local directive can call 3-1-1.

Los Casos Continuan en Ascenso, Se Insiste a los Residentes Usar Cubiertas Faciales

El Departamento de Salud Pública de la Ciudad de El Paso está informando 51 nuevos casos de COVID-19, lo que eleva el número acumulado del condado a 1,080, el número de muertes sigue siendo de 22.

Hasta la fecha, 514 personas se han recuperado de COVID-19; en consecuencia, hay 544 casos activos dentro del condado. Los casos positivos en el Condado de El Paso incluyen 569 mujeres y 511 hombres; ver gráficos y mapa adjuntos. Hay 71 pacientes hospitalizados, y 40 de los hospitalizados están actualmente en la UCI.

Si bien los laboratorios privados solo deben informar los números positivos, el Departamento de Salud Pública ha estado trabajando con los laboratorios privados para obtener sus números totales. Sobre la base de este informe, se estima que se han realizado más de 10.200 pruebas.

El Departamento de Salud Pública pronto comenzará las pruebas de anticuerpos con un subconjunto de trabajadores de seguridad pública y atención médica para permitir que el personal analice el proceso en preparación para expandir las pruebas especiales al público. La prueba de anticuerpos es un análisis de sangre que indica si una persona puede haber estado expuesta previamente a COVID-19 y haber desarrollado anticuerpos.

Los funcionarios de la ciudad y el condado están revisando la actual Directiva de emergencia local en respuesta a las enmiendas del gobernador Greg Abbott de hoy para expandir las oportunidades comerciales en un esfuerzo por reabrir la economía de Texas.




Gráfico muestra el aumento de casos y muertes por día a día. A partir de hoy, tenemos 1080 casos positivos y 22 muertes.

"Solo podemos continuar reabriendo nuestra economía si la comunidad hace su parte en la distancia social, se cubre la cara y no se reúne", dijo el alcalde Dee Margo. "Es fundamental que todos, las empresas y los residentes, sigan estas pautas para no poner en peligro nuestra salud pública".

El Dr. Héctor Ocaranza, Autoridad de Salud de la Ciudad / Condado, recuerda al público que el Condado de El Paso todavía está viendo casos positivos a diario y por esa razón aún debe trabajar para protegerse a sí mismos y a sus seres queridos.

"Si amas a tu madre, abuelas, tíos, hermanas, cualquier figura materna en tu vida muéstrelas tu amor al no visitarlos en persona este Día de la Madre. Deles el regalo de salud y vida, y manténgalos a salvo de COVID19 ", dijo Ocaranza. "Deja de poner excusas sobre por qué está bien visitar a familiares y amigos que no viven en tu hogar inmediato. Las reuniones sociales simplemente no están permitidas. Lo que significa que las reuniones sociales consisten en cualquier persona que no viva en su hogar inmediato, como tíos, tíos, abuelos, etc. están prohibidos. Necesitamos que todos se tomen esto en serio y se cuiden unos a otros y no se arriesguen a perder a un ser querido ".

Se recuerda nuevamente al público que los revestimientos para la cara son obligatorios a nivel local, pero no se requieren para cualquier persona que tenga problemas para respirar, esté inconsciente, incapacitado o haga ejercicio al aire libre y no a menos de 6 pies de cualquier otra persona que no pertenezca al mismo hogar. El uso de una cubierta facial no es un sustituto del mantenimiento del distanciamiento social de 6 pies y del lavado de manos, ya que estos siguen siendo pasos importantes para frenar la propagación del virus.

Se recomienda que los revestimientos faciales se limpien a diario. Las personas deben tener cuidado de no tocarse los ojos, la nariz y la boca al quitarse la cubierta de la cara y lavarse las manos antes y después de quitarse la cubierta.

Se alienta a los residentes a denunciar el incumplimiento llamando al departamento de policía a la linea de no emergencias al (915) 832-4400. Cualquier persona que tenga preguntas sobre la directiva local puede llamar al 3-1-1.

Se pueden hacer preguntas de salud sobre COVID-19 llamando a la línea directa 21-COVID que está operativa de 7 a.m. a 8 p.m. De lunes a viernes y de 10 a.m. a 6 p.m. Sábado y domingo. Symptoms

Symptoms may appear 2-14 days after exposure.

Call your healthcare provider if you develop symptoms, and have been in close contact with a person known to have COVID-19 or if you have recently been in an area with ongoing spread of COVID-19.

Patients with COVID-19 have reportedly had mild to severe respiratory illness. Symptoms can include:



- Fever
- Cough
- Shortness of breath

How It Spreads

The virus is thought to spread mainly from person-to-person, and possibly by touching your mouth, nose, or eyes after touching an infected surface.

Person-to-Person spread is defined as:



- Between people who are in close contact with one another (within about 6 feet).
- Through respiratory droplets produced when an infected person coughs or sneezes.

These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.




